1. Introduction

This meeting of the Decommissioning Review Working Group (DRWG) was part of the second joint meeting of FaSa. The meeting took place on Wednesday 10-12-09.

2. Meeting objectives

The meeting objectives were to:

- Organize the WG;
- Refine and agree upon the approach to be taken in the chapter;
- Assign preliminary writing assignments;
- Decide upon a date for the first writing team meeting in Vienna.

The meeting was chaired by Dominick A. Orlando (US). A formal agenda was not used.

A list of the WG participants is provided in Appendix A.

3. Work performed

The first area that the WG focused on was the scope of the chapter. The original scpe was to prepare recommendations on approaches to review the implementation of the results of decommissioning safety assessments in the decommissioning planning throughout the facility life cycle. After significant discussion the WG agreed that a more appropriate approach would be to prepare recommendations on the approaches to review the implementation of the results of decommissioning safety assessments during decommissioning. This revised approach was determined to more appropriate as it would not result in duplicative efforts and would focus on those areas that were important to safe and effective decommissioning.

The second portion of the meeting focused on the development of the draft chapter outline. The agreed draft Chapter outline is included in Appendix B. In addition, the WG agreed that a suitable time/location for the first writing team meeting would be late May/early June 2010 in Vienna.

Finally, the WG discussed and agreed that a new Chapter should be prepared (by the DRWG) that focused on License/Permit Termination and/or Site release. These areas were originally in the remit for the Termination WG but during the meeting it was determined that this WG would be better suited to develop this information.
