Explanatory Note

Preparation, Conduct and Evaluation of Exercises for Detection of and Response to Acts Involving Nuclear and Other Radioactive Material out of Regulatory Control (NST050)

The draft text for review, entitled *Preparation, Conduct and Evaluation of Exercises for Detection of and Response to Acts Involving Nuclear and Other Radioactive Material out of Regulatory Control,* was prepared as a draft Technical Guidance publication to be issued in the IAEA Nuclear Security Series and has already been reviewed through consultants' meetings, as well as by the Nuclear Security Guidance Committee (NSGC).

The objective of this draft text, as accepted by the NSGC, is to provide practical guidance on the design and delivery of exercises for nuclear security systems and measures for the detection of and response to acts involving nuclear and other radioactive material out of regulatory control. This Technical Guidance publication is intended for competent authorities involved in the preparation, conduct and evaluation of nuclear security exercises, including law enforcement agencies, customs, border security forces, regulatory bodies and technical and scientific support organizations.

Comments are requested in relation to:

- Relevance and usefulness Are the stated objectives appropriate, and are they met by the draft text?
- Scope and completeness Is the stated scope appropriate, and is it adequately covered by the draft text?
- Quality and clarity Does the guidance in the draft text represent the current consensus among specialists in the field, and is it expressed clearly and coherently?

Comments of an editorial nature will be considered; however, it should be noted that the draft text will be comprehensively edited by the IAEA Secretariat.

Any comments should be made in English, should refer to the relevant paragraph number in the draft text being reviewed, and should propose alternative text where appropriate. Please use the attached Form for Comments to record all comments.
